Student Voice - Taylor Hunsaker, Running Start Student at the Gig Harbor Campus

Taylor is a senior at Gig Harbor High School and a full time Running Start Student at TCC this year. She moved to Washington last year and three days into high school, found out about Running Start from another student. She enrolled in the program full time and took two classes at the high school her first quarter. She also participates in volleyball, track, and the National Honor Society at Gig Harbor. Taylor spends time as a Running Start Ambassador for TCC assisting new students with questions, scheduling, and homework. Currently she has all online classes at TCC due to travelling between Washington and Michigan with her parents. She will graduate in June 2018 with her high school diploma and an Associate's Degree from TCC. She plans to attend Boise State University to major in Math and become a Teacher.

B. Veteran Enrollment by Valerie Robertson

Valerie Robinson reviewed the mission of the Veterans Advisory Group that began on campus in 2014. There are currently ten committee members for the 2017-18 academic year. Focus areas of service and support for military students and dependents include Outreach & Recruitment, Entry Points, First Quarter support, and Events & Activities. The focus is to provide supports that will positively affect Veterans as they make the transition from active duty to veteran status.

Data collection for veteran enrollment only includes those students receiving benefits from the government. The State Board is currently developing a ctcLink dashboard that will enhance data collection for the 8 Keys of Excellence for Veteran Students."

- HD- 101 enrollment increase
- Campus training for staff and faculty
- A Veteran segment to the New Student Orientation & Advising sessions

- Vet Corp Navigator Report

New Initiatives include Green Zone Training and the addition of two new Advisory Group members.

C. Gig Harbor Campus Update by Janine Mott

Credit enrollment is holding strong at the Gig Harbor Campus. This year, the schedule was pared down so there are fewer classes offered but they do not overlap so students are not experiencing scheduling problems. Very few classes have been cancelled with this new scheduling model.

Melanie Johnson started as the GHC Administrative Assistant on April 2. KC Bitterman's last day at GHC is April 12. On January 23, Advising attended a college transfer fair at Henderson Bay High School. On January 30, TCC Gig Harbor hosted 18 colleges to provide transfer information to students. On April 11, 16 colleges were on campus with information.

The campus held their Staff Meeting on April 10 with a presentation from Will Howard and Wendy Jackson on safety and security. The art presentation in the lobby called "Night Sky" is by artist Lois Beck. There will be a reception at 5:00 p.m. on April 26.

FACULTY EMERITUS

BACKGROUND

In 2006, a policy was instituted to recognize outstanding service to Tacoma Community College and its students by granting the honorary status of "Faculty Emeritus" to selected retired members of the college's faculty. All college faculty members who have ten years of full-time tenured academic employee service with, and who retire with tenured faculty status from, Tacoma Community College are eligible to be considered for the honorary status of Faculty Emeritus. "Faculty Emeritus" is a designated honorary status that may be conferred upon a retired member of the tenured faculty or in anticipation of the retirement of a faculty member, effective upon retirement, who has demonstrated the very highest and most outstanding service to the college and its students.

A request for emeritus status for a faculty member must be made in writing by a dean to the Executive Vice President of Academic and Student Affairs. The letter of request includes the faculty member's qualifications for the title and lists the outstanding service areas to the college and students during the faculty member's tenure at Tacoma Community College. The Executive Vice President will take the recommendation to the voting members of the Instructional Council for discussion of endorsement and report the outcome to the President. Upon recommendation from the President and approval by the Board of Trustees, the faculty member will then be granted "Faculty Emeritus" status. The President will publish the faculty member's appointment to emeritus status to the campus community.

STATUS

Instructional Council approved the nomination on April 9, 2018.

RECOMMENDATION

The Co-Presidents recommend that the Board of Trustees grant Linda Duchin Emeritus status.

I would hereby like to request that Emeritus Professor status be granted to Dr. Linda Duchin. Dr. Duchin served Tacoma Community College between 1986 and 2017 as Professor of Anthropology. During her 31 years of service to TCC Dr. Duchin achieved many accomplishments each of which benefitted and enhanced our students' educational experienced and positively affected the quality of learning and the quality of our community here at TCC.

During her tenure at TCC, Dr. Duchin was awarded the Faculty Excellence Award and the Outstanding Faculty Contribution Award. Dr. Duchin made a significant and lasting difference to our institution and I highly recommend that her achievements and contributions to TCC be recognized by awarding Dr. Duchin emeritus status.

PURPOSE

To recognize outstanding service to Tacoma Community College and its students by granting the honorary status of "Faculty Emeritus" to selected retired members of the college's faculty.

TO WHOM DOES THIS POLICY APPLY

All college faculty members who have 10 years of full-time tenured academic employee service with, and who retire with tenured faculty status from, Tacoma Community College are eligible to be considered for the honorary status of Faculty Emeritus.

REFERENCES

DEFINITIONS

Faculty Emeritus Status—status granted to select retired members of the College's tenured faculty who have demonstrated the very highest and most outstanding service to the college and its students.

POLICY

"Faculty Emeritus" is a designated honorary status that may be conferred upon a retired member of the tenured faculty or in anticipation of the retirement of a faculty member, effective upon retirement. Conferring of this title is not automatic upon retirement. The title confers academic status and rank and shall be conferred based upon individual distinction and quality of contribution and service to the College and its students. The "Faculty Emeritus" rank carries no formal employment relationship, associated responsibilities or compensation.

The college may choose to rescind the emeritus status designation from a faculty member at any time.

QUALIFICATIONS

Any full-time academic employee may qualify for emeritus status upon retirement and after 10 years of service to the college as a tenured full-time academic employee.

Any qualifying faculty member who retired prior to the approval of this policy may be appointed to such status retroactively to the date of his/her retirement.

Persons who hold an emeritus title at another institution are not eligible for an emeritus title from Tacoma Community College.

HONORS AND PRIVILEGES

The College may offer to Emeritus faculty certain honors and privileges. Such honors and privileges are at the discretion of and as defined by the College. The honors and privileges afforded emeritus faculty may include the following:

- Business cards provided by the college with the title of "Faculty Emeritus."
- A faculty identification card with title "Faculty Emeritus."
- A college- provided e-mail account with the domain name the college uses. (i.e. afaculty@tacomacc.edu) as well as access to the campus network if requested.
- Listing in the college catalog, the commencement program, and other publications as the college deems appropriate.
- TCC Library rights and privileges comparable to those available to non-retired tenured faculty.
- Access to campus, athletic and community events, performances, and publications, and use of College facilities (e.g. Fitness Center), comparable to those available to non-retired tenured faculty.
- An invitation to participate in commencement activities each year in a comparable manner to non-retired tenured faculty.
- A parking pass.
- Participation in Institutional Advancement and Foundation activities and events in a comparable manner to non-retired tenured faculty.
- Participation in community relations activities, interacting with community groups in a manner comparable to a non-retired tenured faculty member.

PROCEDURE

A request for emeritus status for a faculty member must be made in writing by a dean to the Vice President of Academic and Student Affairs. The letter of request shall include the faculty member's qualifications for the title and list the outstanding service areas to the college and students during the faculty member's tenure at Tacoma Community College. The Vice President will take the recommendation to the voting members of the Instructional Council for discussion of endorsement and report the outcome to the President.

Upon recommendation from the President and approval by the Board of Trustees, the faculty member will then be granted "Faculty Emeritus" status. The President will publish the faculty member's appointment to emeritus status to the campus community.

Trustee Authorization under the College Naming Policy

5/9/18

BACKGROUND

As the need for private donations increases, there is an opportunity for Tacoma Community College to facilitate gifts by naming College structures and programs in honor of persons who have provided significant service to the College or who have made major financial contributions. This will enhance the College's ability to respond to the needs of TCC students and the community and to provide a level of excellence in programs and services that would otherwise not be possible. To that end, the College seeks to provide appropriate recognition to donors for their generosity. Although such recognition may take many forms (thank you letters, press conferences, etc.), this policy seeks to establish guidelines for the naming of facilities and programs. This policy is intended only as a guide and allows for flexibility on a case-by-case basis.

TO WHOM DOES THIS POLICY APPLY

The policy applies to all faculty, staff and administrators, board members, donors, students, volunteers, outside advisors, or consultants who may be involved in any area relating to naming items at the College

STATUS

Tacoma Community College is in the process of establishing a Food Pantry to serve students and the TCC community. Food insecurity has been identified by the college community as an area in which the college and its resources may be utilized to offer food and supplies free of charge to those who need them.

TCC Foundation board member Max Harned and Margi Harned have a strong desire to help TCC address the issue of food insecurity. By providing a gift of \$50,000 to the TCC Foundation, Max and Margi Harned seek to utilize their generous gift to be used to offset operating the costs of the food pantry.

In recognition of the Harned's very generous pledge, the TCC Foundation would like to honor them by naming the food pantry the "Max and Margi Harned Titan Food Pantry."

RECOMMENDATION

The final authority for any naming, memorial or tribute decision rests with the President and the College Board of Trustees. Former Co-Presidents Mary Chikwinya and Bill Ryberg recommend that the Board of Trustees approve the space designated for a food pantry in Building 17 the "Max and Margi Harned Titan Food Pantry."
