Associate in Nursing (DTA/MRP)

TCC's Registered Nursing program prepares the student for a career as a Registered Nurse. Upon satisfactory completion of the curriculum, the student is awarded an Associate in Nursing – Direct Transfer Agreement/Major Related Program (DTA/MRP) degree and is eligible to take the National Council Licensure Examination (NCLEX) for Registered Nursing.

Essential Requirements for Nursing Students

The nursing profession is a highly respected field. The reasons for this are many, but largely because patients put their lives in our hands. Nurses must be worthy of that trust. The nursing program has the responsibility to assure the public that its students and graduates are competent in all of these areas.

The law relating to nursing care states in WAC 246-840-700, "Each individual, upon entering the practice of nursing, assumes a measure of responsibility and public trust and the corresponding obligation to adhere to the standards of nursing practice. The nurse shall be responsible and accountable for the quality of nursing care given to clients. This responsibility cannot be avoided by accepting the orders or directions of another person." Nursing students and graduates are held to this law.

The TCC Nursing Program curriculum is intended to lead to a student's eligibility for licensure as a registered nurse. The curriculum requires students to engage in diverse, complex, and specific experiences essential to the acquisition and practice of essential nursing skills and functions. These abilities are essential as they constitute core components of nursing practice. There is a high probability that negative consequences will result for patients/clients under the care of nurses who fail to demonstrate these abilities. A program preparing students for the practice of nursing must attend to these essential functional abilities in the education and evaluation of its students.

This statement of Technical Standards identifies the functional abilities the TCC nursing faculty deem to be essential to the practice of nursing. The Technical Standards are reflected in the Nursing Program Learning Outcomes, which are the basis for teaching and evaluating all nursing students. Application Deadlines

- Fall and Winter Quarters (full-time): July 1
 Accepting applications June 1-July 1
- Spring Quarter (full-time): Jan. 7
 Accepting applications Dec. 1-Jan. 7

NOTE: It is understood that people applying during the June application period are submitting for both fall AND winter quarters. Students drawn with "even" position numbers

will be placed in the fall quarter cohort and "odd" position numbers will be used to fill winter quarter. Alternates will be called up based on the same process, even – fall, odd – winter. If a student is not able to start at the appointed quarter, they will need to reapply to the program at the next deadline.

Program Cost

Figures are estimates for the six-quarter DTA/MRP program only and are subject to change. Nursing program courses are consistently fully enrolled, do not have "space available" and cannot allow for tuition waivers per RCW 28B.15.558. Any request for tuition waiver in this program will be denied.

Full-Time Option

The nursing courses in the generic program are taught in a six-quarter sequence over a two-year period.

The full-time student will complete theory and clinical courses each quarter. It is strongly recommended that students work less than 12 hours per week. It is also required, for safety reasons, that students do not work for at least 8 hours immediately prior to any clinical experience.

Entry into the generic program occurs in fall, winter and spring quarters.

Please note: The Tacoma Community College campus has an 8-week summer quarter. If your 6th quarter of the nursing program is in the summer quarter, you will have a 10-week quarter.

Getting Ready to Submit Prerequisites for Approval

- Coursework completed at other colleges must be evaluated by TCC Enrollment Services office.

- Transcripts must be submitted by the application deadline.

Nursing Program Prerequisites

All **FACTORED PreREQUISITES** must be completed <u>before</u> applying to the Nursing Program. Each course must be successfully passed within two atempts to achieve a grade of "B" or higher. These attempts include all academic withdrawals "W" and "I, WI, V and Z" as well as grades "B-" and below. There is no expiration date for prerequisites. Unsuccessful attempts more than five years old are disregarded.

Qualification / Weighted Points

After submitting an application, all documents will be evaluated. Each applicant will be awarded a score that is comprised of the following areas:

1. Base Points (40 points)

40 base points are awarded to all students who meet the basic nursing program requirements by the published deadline.

- » Completion of the six factored prerequisites (see Prerequisites, page 4)
- Completion of the non-factored prerequisites (see Prerequisites, page 4)
- » Cumulative college-level GPA of 2.5 or higher (all courses, all colleges).
- » ATITEAS Exam (see ATITEAS Exam, this page)
- » Submission of nursing application and transcripts from outside institutions by the deadline.
- » Nursing Assistant Certification (NAC) Must have an active Washington state NAC.

NOTE: If you have taken the state exam for licensure and received passing scores but you have not become licensed yet, you can submit the written and skills test document from Pearson Vue in your application. If you are selected in the lottery, your spot will be dependent on your license being active two weeks before the first day of the quarter in which you were accepted.

2. Weighted Plus Points (max 60 points) Additional points are awarded for the following:

- » Biology Prerequisites (max 30 points)
 Each grade of "A-" or higher in the biology prerequisites (BIOL& 241, BIOL& 242, and BIOL& 260) are weighted as follows: A- (3.7) = 10 pts
- » Military Service (max 10 points) Students with military service (past or present) are awarded 10 additional points. Does not apply to spouses or family members. Minimum of 90 days service and honorable discharge.
- » TCC Credits (max 10 points)
 Students who have taken college-level credit courses at TCC are awarded the following additional points:
 - \approx 30 or more college-level credits taken at TCC are awarded 10 points.
 - ≈ 15-29 college-level credits taken at TCC are awarded 5 points.
- **3. Weighted Negative Points** (max -15 points)

 Points will be subtracted from the 40 base points for the following:
 - » Each course retake in BIOL& 241, 242 or 260 will subtract 5 points.
 - » Retakes more than five years old will not be penalized.

admission factors

ATI TEAS Exam

TCC requires all nursing program applicants to take the Test of Essential Academic Skills (ATITEAS) exam. The objectives used on ATITEAS are those deemed most relevant to measure entry level academic readiness for nursing program applicants.

REQUIRED: A minimum overall score of 70% and minimum scores in each category as follows: Reading 75%, Math 72%, Science 63%, English 70%. Students are allowed two attempts per year. This means that you can't have more than two attempts in the 365-day period prior to the published application deadline for the cycle for which you are applying (example: If the deadline is July 1, 2019 you can only have two attempts from July 1, 2018 to July 1, 2019). All requirements must be met on one test; you can't use scores from multiple tests to meet the requirement. Results can be no more than four years old at application deadline.

Many students have already taken the ATITEAS exam, as it is a common requirement for nursing program applications. If you still need to take an ATITEAS exam, you will be able to do so here at TCC.

How to register for the ATI TEAS at TCC:

- Go to www.atitesting.com and create a personal account. You will also be asked to provide student information. Be sure to select "Tacoma CC" as the school.
- You are not required to take the ATITEAS at Tacoma Community College.
- After creating an account, log in, and select the "Online Store" to register for the TEAS. In the online store, select "TEAS" located in the lefthand column under "Register for..."
- On the next screen you will need to select the state and city, and then you will have the option to select a testing time and location.
- There is a testing fee required to finish registration. After purchase, you will receive detailed instruction of where to go, the time of testing, and expectations of what to bring on the day of your assessment. Be sure to fulfill these expectations or you will not be able to test at your scheduled time.

ATI TEAS Study Preparation:

There are many resources available to prepare for the ATITEAS. The resources best oriented towards this assessment are also available through ATI and located in the online store https://store.atitesting.com/.

These resources are produced and organized by the same developers of the ATITEAS assessment. Look under the ATITEAS "Shop by", and there are different study solutions for ATITEAS success.

The resource with the most value for preparation and ATITEAS success is the ATITEAS Comprehensive Study Package. This package includes two ATITEAS practice assessments that mirror the assessment. It also includes the ATITEAS Study Manual.

Applying to TCC's Nursing Program

Online Application Process


TCC's nursing program uses an online admission process. To apply you must be an admitted or registered student at Tacoma Community College and have access to the myTCC portal and have a TCC student email account.

How to access the application

- Sign into the TCC student portal (requires you to have an active TCC student account)
- 2. Click on the square icon (in the upper right corner), to expand options.—
- 3. Select All Applications.



4. Select the Alliea Health/Ivursing link.



- 5. Select your application choice.
- 6. Upload:
 - a. TEAS test results;
 - b. NAC license;
 - c. Military document. If you don't have military service upload a document and write "no experience."
 - d. A list of incoming official transcripts. Four documents must be uploaded or your application will not submit properly.
- 7. Click Submit and you are finished.
- 8. When you have completed the application, the system will send a confirmation to your TCC email. It is the responsibility of the applicant to ensure that all application materials and required documentation are received by the application deadline. Students do not need to wait UNTIL the deadline date to submit an application.

After Applying

In the first few weeks following a deadline, applications are evaluated for accuracy and weighted items are scored.

If your application is disqualified for any reason, you will be notified by TCC student email prior to the lottery taking place. It is your responsibility to check your email regularly for any communication regarding your application. Once all applications are processed, qualified applicants and weighted scores will be posted on the website for review.

Qualified applicants are entered into the TCC nursing lottery, which selects students to fill program openings.

Overview of the Lottery Process

TCC uses a weighted lottery to randomly select qualified students to fill its nursing cohorts. TCC is committed to a fair and open lottery and to avoid any misinterpretation of results, the program has instituted a witnessed verification process.

If your application qualifies, your lottery ID number will be entered into the lottery, including the appropriate weight earned by your application.

Selected applicants will be notified by TCC email one to two days after the drawing. If a student is accepted and then declines, the next randomly generated number will be accepted.

The lottery process will remain in effect for all future application deadlines until further notice.

If Not Selected

If you are not selected and wish to be considered for future drawings, you must reapply. You do not need to resubmit transcripts. You may also wish to explore a Pre-Nursing transfer degree or other allied health program offerings at TCC. Feel free to contact an advisor at 253.566.6091 or advising@tacomacc.edu.

Next Steps

New Student Nursing Orientation

If you are selected and accept a position in the nursing program, you will be required to attend a mandatory orientation. Specific information regarding this orientation will be sent to your TCC email after your acceptance into the program.

The protection of vulnerable populations is paramount in nursing. Students should be aware they will need to meet all minimum requirements of clinical agencies including health clearance procedures.

Transportation & Child Care

It is the student's responsibility to arrange for dependable transportation to and from the school and clinical sites and have reliable child/dependent care available as needed.

Background Check

Certain conviction history will exclude persons from health care employment. This could also exclude a student from certain clinical sites.

Please check the criteria at the following link (https://www.dshs.wa.gov/ffa/disqualifying-list-crimes-and-negative-actions). If you have any charges on the list, please make an appointment with Dr. Jill Edwards, Dean of Nursing, to discuss how this could affect you. Her email address is jedwards@tacomacc.edu.

Additional Requirements:

- Several online health and safety courses
- CPR card Only the American Heart
 Association "Healthcare Provider" or "Basic Life Support (BLS) for Professional Rescuer" will be accepted. Online courses are not acceptable.
- Health Insurance Proof of coverage with coverage period. If the name on the card does not match yours (the student) proof of coverage from the provider is required.
- **Vehicle Insurance** Proof of coverage.
- Drug Screening Various healthcare facilities will require drug screening prior to student's clinical assignments. These results are strictly confidential between student and facility. The screening is not required by TCC.

Proof of Immunizations

- Hepatitis B Series Proof of immunity by vaccination (3 doses) and positive titer.
- » If titer is negative you should talk to your doctor about getting a booster or repeating the series (30-60 days after completion you will repeat the titer).
- » If negative a second time, you are considered a non-responder. Student will be allowed in clinical during repeat series by uploading a Hep B waiver.
- Influenza Proof of immunity by vaccination OR signed waiver. Waiver option can only be used for an egg allergy. You will need to follow additional clinical requirements (i.e. masking, etc.) if you are not vaccinated. This vaccination must be current (based upon current flu season requirements).
- MMR (Measles (rubeolla), Mumps, Rubella) Proof of immunity by vaccination (2 doses) or titer.
- **PPD (TB)** Proof that you don't have TB by Negative Quantiferon test or 2-step PPD.
 - » You complete a 2-step PPD as follows: If the first PPD is negative then you will need to obtain a second PPD within 1-3 weeks. Yearly annuals are required after your 2-step PPD.
 - » If you have a history of positive TB results through BCG or past infection, you must provide proof of negative TB by chest x-ray and submit negative symptom check every 12 months. If you have no proof of a positive TB test, you will need to retest by PPD or provide a current negative Quantiferon test.
- Tetanus/Pertussis (Tdap) If immunized after 06/10/07. Vaccination must be within 10 years. Will not accept Td.
 - Varicella (Chicken Pox) Proof of immunity by vaccination (two doses) or titer.
- COVID-19 Proof of two COVID-19 vaccines.
 Booster vaccines are not required at this time,
 but this is subject to change. You can submit exemption requests for medical or religious reasons, but clinical sites may not accept them.

Eligibility to take the National Licensing Exam for Registered Nurses

Registered Nurses are licensed by the State of Washington. In order to be eligible to take the licensing exam, students must graduate from a state-accredited nursing school. Applicants must file their intent to take the exam 60 days prior to the expected date, with a form supplied by the Associate Dean for Nursing. The exam fees must be paid at the same time. Graduating students must answer the following questions, which are excerpted from the Nursing Practice Law:

- Do you have a medical condition, which in any way impairs or limits your ability to practice your profession with reasonable skill and safety? If yes, please explain.
 - "Medical condition" includes physiological conditions or disorders such as, but not limited to, orthopedic, visual, speech, and hearing impairments, cerebral palsy, epilepsy, muscular dystrophy, multiple sclerosis, cancer, heart disease, diabetes, mental retardation, emotional or mental illness, learning disabilities, HIV disease, tuberculosis, drug addiction, and alcoholism.
 - 1a. If you answered "yes" to question 1, please explain whether and how the limitations or impairments caused by your medical condition are reduced or eliminated because you received ongoing treatment (with or without medications).
 - 1b. If you answered "yes" to question 1, please explain whether and how the limitations and impairments caused by your medical condition are reduced or eliminated because of your field of practice, the setting, or the manner in which you have chosen to practice.
 - If you answered "yes" to question 1, the licensing authority (Board/Commission or Department as appropriate) will make an individualized assessment of the nature, the severity, and the duration of the risks associated with an ongoing medical condition, the treatment ongoing, and the factors in "1b" so as to determine whether an unrestricted license should be issued, whether conditions should be imposed or whether you are not eligible for licensure.
- Do you currently use chemical substance(s) in any way, which impair or limit your ability to practice your profession with reasonable skill and safety?
 If yes, please explain.
 - "Currently" means recently enough so that the use of drugs may have an ongoing impact on one's functioning as a licensee, and includes at least the past two years.
 - "Chemical substances" includes alcohol, drugs, or medications, including those taken pursuant to a valid prescription for legitimate medical purposes and in accordance with the prescriber's direction, as well as those used illegally.
- 3. Have you ever been diagnosed as having or have you ever been treated for pedophilia, exhibitionism, voyeurism or frotteurism?

- 4. Are you currently engaged in the illegal use of controlled substances?
 - "Currently" means recently enough so that the use of drugs may have an ongoing impact on one's functioning as a licensee, and includes at least the past two years.
 - "Illegal use of controlled substances" means the use of controlled substances obtained illegally (e.g., heroin, cocaine), as well as the use of legally controlled substances, not taken in accordance with the directions of a licensed healthcare practitioner.
- Have you ever been convicted, entered a plea of guilty, nolo contendere or a plea similar effect, or had prosecution or sentence deferred or suspended, in connection with:
 - The use or distribution of controlled substances or legend drugs?
 - b. A charge of a sex offense?
 - c. Any other crime, other than minor traffic infractions (including driving under the influence and reckless driving)?
- 6. Have you ever been found in any civil, administrative, or criminal proceeding to have:
 - a. Possessed, used, prescribed for use, or distributed controlled substances for legend drugs in any way other than for legitimate or therapeutic purposes, diverted controlled substances or legend drugs, violated any drug law or prescribed controlled substances for yourself?
 - b. Committed any act involving moral turpitude, dishonesty or corruption?
 - c. Violated any state or federal law or rule regulating the practice of a healthcare profession?
- 7. Have you ever been found in any proceeding to have violated any state or federal law or rule regulating the practice of a healthcare profession? If "yes," explain and provide copies of all judgments, decisions, and agreements.
- 8. Have you ever had any license, certificate, registration, or other privilege to practice a healthcare profession denied, revoked, suspended or restricted by a state, federal or foreign authority, or have you ever surrendered such credential to avoid or in connection with action by such authority?
- 9. Have you ever been named in any civil suit or suffered any civil judgment for incompetence, negligence, or malpractice in connection with the practice of a healthcare profession?

Students who answer "yes" to any of the questions, should make early application to the Washington State Nursing Commission. The Commission acts on each case individually at the time of application for licensure. Provide an explanation and copies of all judgments, decisions, orders, agreements, and surrenders.

A dishonest answer to any of the questions is grounds for revocation of a license in and of itself.
