US Mental Health Crisis A Few Stats

- Every year(1):
 - 1 in 5 adults & 1 in 6 youth (age 6-17) mental health disorder
 - 1 in 20 adults serious mental illness
 - Suicide is the 2nd leading cause of death ages 10-14
- Veterans(1):
 - 20% experience mental illness
 - 6% of males & 13% of female will have PTSD at some point in their life.

Psychedelic-Assisted Psychotherapy (PAP)

- What is PAP?
 - "The use of hallucinogens (or psychedelic drugs) in the treatment of some types of mental or physical illness." (3)
 - "An evidence-based protocol of treatment, where the use of psychedelics, combined with integrative psychotherapy, allows the person's inner healing intelligence to emerge and act as a guide to a more fulfilling life." (4)

Psychedelic-Assisted Psychotherapy

How does PAP Work?:

- Psychedelics cross blood-brain barrier, target serotonin receptors
- Altered perceptions & hallucinations occur quickly
- Hallucinogens support brain neuroplasticity
- Neuroplasticity: Brain's ability to rewire, reorganize, & change itself—modify/awaken neural pathways, in response to new info or new experiences.
- Through Integration Therapy, new insights (information) are received, new perceptions & experiences processed.
- Corresponding intentions, thoughts, patterns afterward help solidify changes, establish new habits, attitudes, behaviors, and more. (5,6)

Psychedelics

What are Psychedelics?

Psychoactive substances that change a person's perception, mood, and cognitive processes, or distort their interpretation of what they perceive. A person may also hallucinate—seeing or hearing things that do not exist or are distorted.

Psychedelics affect all senses, altering a person's thinking, sense of time, and emotions.

Psychedelics

- Drug Classification:
 - Schedule I: Federal Controlled Substance Act of 1970
 - Schedule 1 means
 - Unacceptable lack of safety
 - High potential for abuse/addiction
 - No currently accepted medical use in treatment in the US (8)

Spotlight on Psilocybin

Plant-based, from "magic" mushrooms
Schedule I Controlled Substance (Federal)
Not FDA-approved to prescribe or use
Research & FDA clinical trial results encouraging
Grass roots efforts to decriminalize (state & local)

Spotlight on Ketamine

- Synthesized drug (not plant-based)
- Schedule III controlled substance (Federal)
 - Moderate to low potential for physical & psychological dependence
 - Abuse potential less than Schedule I & II, more than Schedule IV
 - Examples of Schedule III: Codeine, anabolic steroids, testosterone

Spotlight on Ketamine (continued)

- > FDA approved in 1970 as dissociative anesthesia
 - Quick-acting, short duration, no respiratory system suppression
- FDA approved esketamine (Spravato nasal spray) in 2019 for
 - Depression
 - Major Depressive Disorder with Acute Suicidal Ideation
- Higher dose: Anesthesia, unconsciousness
- Lower dose: Altered consciousness, effects similar to hallucinogens/psychedelics

Are Psychedelics Legal?

- Ketamine: Yes, by prescription
- OR and CO
 - Legalized by ballot, passed with significant margins
 - Oregon opening facilities in 2023
 - Colorado to open facilities in 2024 or 2025
 - Massachusetts may be next to legalize
- Grass roots "Decrim the Plants" efforts
 - Not legal, but low law enforcement priority
 - Small amount/personal use & growing (allowed)
 - 1st passed Oakland, CA
 - Now about 100 similar initiatives passed locally
 - WA: Seattle & Port Townsend

SB5660 filed 1/2023

Access to psilocybin services for people 21 & older

 "AN ACT Relating to access to psilocybin services by individuals 2 21 years of age and older; amending RCW 7.48.310 and 49.60.180; 3 reenacting and amending RCW 69.50.101 and 43.79A.040; adding a new 4 section to chapter 15.130 RCW; adding a new chapter to Title 69 RCW; 5 prescribing penalties; providing an effective date; and declaring an emergency."


2/1/23 Referred to Committee on Health & Long Term Care. Passed Committee

Are Psychedelics Legal? (continued)

- Per 7/2022 article in The Intercept, Biden Admin "anticipates regulators will approve MDMA & psilocybin within 2 years for designated breakthrough therapies for PTSD and depression respectively"
- Bottom line:
 - Hot topic, lots of interest
 - Encouraging research results, more to come
 - Lots of activity around decriminalization and legalization

Purchase


- Received medication via mail
